Its premise is that an historical realism is essential in order to develop a route out of the post-Oslo

impasse that extended and solidified the power imbalance under the auspices of 'peace'. The book includes chapters from experts across the disciplines of anthropology, economics, law, political science and sociology to map out and critically assess the impacts and responses to this 'peace' in different geographical and political settings.
